### Havfram Code of Conduct for Business Partners

#### Introduction

At Havfram, we believe that acting ethically and responsibly is not only the right thing to do, but it is in the core of our DNA.

Our environmental stewardship also includes the low-emission profile of our newbuild vessel, which are specially designed to reduce the carbon footprint of the offshore wind industry.

#### **Compliance with applicable laws**

Havfram's business partners shall comply with applicable laws and regulations.

#### Fair business

Havfram is committed to conducting business in a fair and proper manner.

Havfram's business partners shall uphold the highest standards of business ethics, respect local laws and not engage in any form of corruption, bribery, fraud, kickbacks, illegal gratuities or extortion.

Havfram has a zero-tolerance policy against corruption in any form.

#### **Fair competition**

Havfram strictly prohibits anti-competitive agreements or conduct, including fixing prices, restricting the supply of goods or services, bid rigging and market sharing. We require our Business Partners to commit to free and fair competition and to abide by relevant competition laws and regulations.

#### **Human Rights**

Havfram's business partners shall respect internationally recognized human rights.

Havfram will not use or accept any form of human trafficking, forced labor or prison labor nor accept anyone to do so on our behalf.

Havfram recognizes the employees right to freedom of association and collective bargaining in accordance with applicable laws and regulations.

Havfram requires that employees of our business partners are treated with respect and dignity.
